- March 1, 2007
 - > All positive recommendations by the Dean (and all positive reviews prior to the Dean's review for final tenure regardless of the Dean's recommendation) forwarded to the University P&T Committee.
 - > 2nd-year dossiers completed at the Unit level and forwarded to the Dean's Office.
- March 2-30, 2007
 - > College P&T Committee's review period of 2nd-year dossiers.
 - > Dean's review period of 4th-year dossiers.
- March 30, 2007
 - > College P&T Committee completes 2nd-year reviews and forwards to the Dean.
- April 2-30, 2007
 - > Dean's review period of 2nd-year dossiers.
- April 30, 2007
 - > Dean completes 2nd- and 4th-year reviews and notifies faculty whose appointments will not be continued, in accordance with the provisions of HR-23.
- May 15, 2007
 - > All final decisions on promotion and tenure completed by the President based on recommendations of the Executive Vice President and Provost; all candidates notified of the results of the reviews.
- June 15, 2007
 - > For all faculty not having a promotion or tenure review in 2006-07, annual personnel evaluations completed and faculty informed of results of these evaluations, in writing.
